

SCHEDULE OF REPORTING DATES FOR NONCANDIDATE COMMITTEES

(Revised July, 2015)

REGISTRATION DEADLINE

Organizational Report

The Organizational Report must be filed by a noncandidate committee within ten days of receiving contributions or making expenditures that amount to more than \$1,000, in the aggregate, in a two-year election period; except that within the thirty day period prior to an election, a noncandidate committee shall file an Organizational Report within two days of receiving contributions or making expenditures that amount to more than \$1,000, in the aggregate, in a two-year election period.

A noncandidate committee that makes independent expenditures in an aggregate amount of more than \$500 within the period between fourteen and four calendar days prior to the <u>General Election</u> shall file a Late Expenditure Report. <u>The reports are not required if there are no late contributions or late expenditures.</u> Note: Late contributions and late expenditures will also be reported on the Final Election Period Report.) WARNING

At the conclusion of the General Election on November 8, 2016, noncandidate committees still registered with the Campaign Spending Commission ("Commission") must continue to electronically file reports online in the Noncandidate Committee Filing System until their final disclosure report has a zero balance and a request to terminate is submitted to and approved by the Commission. The first report due after the General Election is the Supplemental Report covering the reporting period of November 9 through December 31, 2016. This report is due on January 31, 2017.
