Craig Connor stated that he was impressed with the State of Hawaii's Energy and Renewable Energy Goals of 100% clean energy by 2045.

- 3. Approved the minutes of the June 9, 2015 meeting.
- 4. It was announced that Tim Hiu and Gary Chock have retired from the SBCC. Willard Nishigata has replaced Tim Hiu representing the City and County of Honolulu on the council. Gaur Johnson has replaced Gary Chock representing SEAOH on the council. This will be Doug Haigh's last day on the council. The election of officers involves electing a new chair and others annually. Doug Haigh made the motion to nominate officers, it was unanimously voted on and resulted in the new Chair: Chief Socrates Bratakos (State Fire Council) and Vice Chair: Willard Nishigata.
