for the consideration of Sixty Two 85/100 (\$62 85/100) Dollars paid into the Exchequer, and for the further consideration of his having complied with terms and conditions in agreement of Sale, dated June 21, 1894.

all that piece of land situate at Kaumana in the District of Hilo Island of Hawaii and described as follows:

Lot No. I

Beginning at the pile of stones marked 1 at East angle, from which point the Haw'n. Gov't. Survey and Sta., "Kaumana" bears S. 50° 17' W. true distant 4279 feet, the boundary runs;-

1. N. 30° 28' W. true 80 feet along lava flow;
2. N. 29° 36' W. true 131 feet along lava flow to pile of stones at N. angle;
3. S. 73° 53' W. true 794 feet along Crown Land of Ponahawai;
4. S. 74° 51' W. true 730 feet along same;
5. S. 73° 50' W. true 631 feet along same;
6. S. 74° 04' W. true 93 feet along same to an Ohia post marked $\frac{1}{2}$ at the North west angle.
7. S. 00° 00' E. true 940 feet along Lot #2 to pile of stones marked $\frac{1}{2}$ at the edge of Lava flow.
8. N. 53° 50' E. true 2001 feet along Lava flow to the Initial point.
