LOT 3, Part 1 and LOT 4, Part 1 (Kula)

Beginning at the southwest corner of Lot 4, Part 1, the southeast corner of Lot 5, Part 1 of Ualapue Lots (Grant 3796 Apana 1 to Kawelo, w) and on the northerly side of The Government Main Road, the approximate coordinates of said point of beginning referred to Government Survey Triangulation Station "MANAWAI" being 2946.0 feet North and 1907.0 feet East, as shown on Government Survey Registered Map 1773, thence running by azimuths measured clockwise from True South:

1. 167° 34' 702.0 feet along Lot 5, Part 1 of Ualapue Lots (Grant 3796 Apana 1 to Kawelo, w);
2. 259° 40' 272.0 feet along Government Land;
3. 347° 34' 677.2 feet along the westerly side of a 20-foot Road;

5. 106° 40' 79.0 feet along L.C.Aw. 4209 Apana 2 to Kauhikoakoa and L.C.Aw. 3975 Apana 1 to Hulihae;
6. 354° 30' 23.7 feet along L.C.Aw. 3975 Apana 1 to Hulihae;
7. 91° 20' 41.9 feet along L.C.Aw. 4194 Apana 3 to Kuluwaimaka;
8. 179° 00' 30.0 feet along L.C.Aw. 4194 Apana 3 to Kuluwaimaka;
9. 168° 15' 81.5 feet along Lot 5, Part 2 of Ualapue Lots (Grant 3796 Apana 2 to Kawelo, w) to the point of beginning and containing an Area of 0.53 Acre.
