Beginning at a $1\frac{1}{2}$ inch pipe at the Southwest corner of this lot and the North corner of Lot 51, the coordinates of said pipe referred to the Government Survey Trig. Station "Puu-o-Nale" being: 6578.3 feet North and 5701.5 feet East, as shown on Government Survey Registered Map No. 2579, and running by true azimuths:-

1. 180° 00' 1068.0 feet along Kaauhuhu Road to a $1\frac{1}{2}$ inch pipe;
2. 290° 00' 85.7 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
3. 265° 52' 317.0 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
4. 316° 30' 285.6 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
5. 287° 00' 147.0 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
6. 336° 35' 73.7 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
7. 34° 05' 134.5 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
8. 9° 05' 134.3 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;
9. 340° 05' 130.7 feet along Kohala Ditch Company's right-of-way;
10. 353° 25' 101.0 feet along Kohala Ditch Company's right-of-way to a $1\frac{1}{2}$ inch pipe;

- 11. 282° 35' 130.0 feet along Kohala Ditch Company's right-of-way to a 1½ inch pipe;
- 12. Thence Southwesterly along the center of the ravine in the bottom of Honomakau Gulch along Lot 52, the direct azimuth and distance being: 75° 30" 225.0 feet;
- 13. Thence Southerly along same, the direct azimuth and distance being: 9° 29' 262.0 feet;
- 14. Thence Southwesterly along same to a 1½ inch pipe, the direct azimuth and distance being: 48° 17' 315.0 feet;
- 15. 128° 00' 448.2 feet along Lot 51 to the point of beginning.
