NAPILI BEACH LOTS

LOT 8

Napili 4 and 5, Lahaina (Kaanapali), Maui, T. H.

Being portion of the Government (Crown) Land of Napili 4 and 5.

Beginning at a  $\frac{3}{4}$  inch pipe at the northeast corner of this lot, the southeast corner of Lot 9 of Napili Beach Lots, and on the west side of Hui Drive, the coordinates of said point of beginning referred to Government Survey Triangulation Station "MANINI" (Puukolii) being 23793.46 feet North and 5880.27 feet West, as shown on Government Survey Registered Map 4077, thence running by azimuths measured clockwise from True South:-

1. Along the west side of Hui Drive, on a curve to the left having a radius of 80.00 feet, the chord azimuth and distance being:  $359^{\circ} 27' 23''$  16.08 feet to a  $\frac{3}{4}$  inch pipe;
2.  $95^{\circ} 13' 30''$  47.38 feet along Lot 7 of Napili Beach Lots to a  $\frac{3}{4}$  inch pipe;
3.  $50^{\circ} 45'$  151.37 feet along Lot 7 of Napili Beach Lots to a  $\frac{3}{4}$  inch pipe;
4.  $141^{\circ} 50'$  143.00 feet along the northeast side of the Right-of-Way for Stream to a  $\frac{3}{4}$  inch pipe;
5.  $225^{\circ} 25'$  129.00 feet along Government Beach Reserve to a  $\frac{3}{4}$  inch pipe;
6.  $308^{\circ} 19' 30''$  147.23 feet along Lot 9 of Napili Beach Lots to a  $\frac{3}{4}$  inch pipe;
7.  $275^{\circ} 13' 30''$  45.43 feet along Lot 9 of Napili Beach Lots to the point of beginning and containing an Area of 22,633 Square Feet.

Reserving to the Territory of Hawaii a Storm Drain Easement over, under and across the hereinabove described Lot 8, as shown on plan attached hereto and made a part hereof and more particularly described as follows:

Beginning at a  $3/4$  inch pipe at the east corner of this easement and at the **end** of Course 2 of the hereinabove described Lot 8, thence running by azimuths measured clockwise from True South:-

1.  $50^{\circ} 45'$  151.37 feet along Lot 7 of Napili Beach Lots to a  $3/4$  inch pipe;
2.  $141^{\circ} 50'$  10.00 feet along the northeast side of the Right-of-Way for Stream;
3.  $230^{\circ} 45'$  141.00 feet;
4.  $275^{\circ} 13' 30''$  14.27 feet to the point of beginning and containing an Area of 1462 Square Feet.
