Being a portion of R.P. 5671, L.C.Aw. 8521-B, Part 1 to G. D. Huet conveyed to the Territory of Hawaii by Richard Smart by Deed dated June 12, 1956 and recorded in Liber 3126 Pages 36-55 (Land Office Deed 13596)

Beginning at a pipe at the southeast corner of this lot, and on the westerly side of Mamalahoa Highway, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU PA" being 5906.05 feet North and 9364.47 feet East, as shown on Government Survey Registered Map H.S.S. Plat 420, thence running by azimuths measured clockwise from True South:-

1. 96° 00' 770.00 feet along portion of L.C.Aw. 8521-B, Part 1 to A. D. Huet to a pipe;
2. 186° 00' 874.65 feet along Part B of Lot 9 of Lalamilo Farm Lots to a pipe;
3. Thence along the southwest side of 40-Foot Roadway on a curve to left having a radius of 1020.00 feet, the chord azimuth and distance being 280° 51' 43" 172.90 feet to a pipe;
4. 276° 00' 547.72 feet along the southwest side of 40-Foot Roadway to a pipe;
5. Thence along the southerly side of 40-Foot Roadway on a curve to the right having a radius of 50.00 feet, the chord azimuth and distance being: 321° 00' 70.71 feet to a pipe;
