1. 208° 58' 100.0 feet along the east side of proposed 40-foot road;
2. 287° 00' 200.0 feet along Lot 8, Wailea Beach Lots;
3. 28° 58' 100.0 feet along government land;
4. 107° 00' 200.0 feet along Lot 10, Wailea Beach Lots to the point of beginning.

Please be informed that by Exchange Deed dated October 1, 1942, Kenneth D. Bond conveyed to the Territory Parcel 1 of the Mahukona-Niulii Road Realignment containing an area of 1.240 acres situate at Iole, North Kohala, Hawaii, as shown on your C.S.F.Nos. 9355-58.

In exchange therefor the Territory conveyed to Kenneth D. Bond 3 parcels, being Lots 9, 10, and 11, Wailea Beach Lots, situate at Lalamilo, South Kohala, Hawaii, containing a total area of 1.350 acres, as shown on your Carton No. 63, by Land Patent No. 11,087.
