Kahakuloa, Wailuku (Kaanapali), Maui, Hawaii

Being a portion of the Government (Crown) Land of Kahakuloa

Beginning at a pipe and ahu near the top edge of Mana Gulch on the south boundary of this parcel of land, the northwest corner of Grant 12981 to Manuel S. Novite, Jr. (Lot 4 of Kahakuloa Homesteads, Subdivision of 1938), and the northeast corner of Grant 12758 to David Nobriga and Barbara L. E. Nobriga (Lot 5 of Kahakuloa Homesteads, Subdivision of 1938), the coordinates of said point of beginning referred to Government Survey Triangulation Station "KAHAKULOA" being 6764.57 feet South and 3243.74 feet East, as shown on Government Survey Registered Map 3031, thence running by azimuths measured clockwise from True South:-

1. Along Grant 12758 to David Nobriga and Barbara L. E. Nobriga (Lot 5 of Kahakuloa Homesteads, Subdivision of 1938), along top of pali and across Mana Gulch at the waterfall, the direct azimuth and distance being: 116° 16' 473.31 feet to a pipe and ahu on top of ridge;

Thence up along the middle of the ridge, along Grant 12758 to David Nobriga and Barbara L. E. Nobriga (Lot 5 of Kahakuloa Homesteads, Subdivision of 1938) for the next two (2) courses, the direct azimuths and distances between points on the middle of said ridge being:

2. 50° 04' 30" 844.05 feet to a pipe and ahu;
3. 67° 55' 30" 649.89 feet to a pipe and ahu on the north side of the Government Main Road (50.00 feet wide);

4. Thence down the middle of the spur ridge, along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938), the direct azimuth and distance being: 175° 43' 306.00 feet to a pipe and ahu;
5. 153° 40' 30" 1288.95 feet along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938), crossing Malalokai Gulch to a pipe and ahu;
6. 244° 59' 227.10 feet along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938) to a pipe and ahu;
7. 194° 52' 331.00 feet along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938) to a pipe and ahu;
8. 276° 09' 261.95 feet along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938) to a pipe and ahu;
9. 269° 02' 349.21 feet along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938) to a pipe and ahu;
10. 230° 44' 406.10 feet along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938) to a pipe and ahu;
11. Thence along the top edge of the pali, along Grant S-13945 to Manuel Nobriga (Lot 6 of Kahakuloa Homesteads, Subdivision of 1938), the direct azimuth and distance being: 205° 13' 756.49 feet to a pipe and ahu;
12. 346° 00' 850.00 feet down the pali to a point near the seashore in Malalokai Gulch;
13. 294° 00' 300.00 feet across Malalokai Gulch near the seashore;
14. 340° 00' 700.00 feet near the seashore to a point in Mana Gulch near the mouth of the stream;
15. 286° 25' 521.00 feet up the pali to a pipe and ahu near the top of said pali;

Thence along the top of Mana Gulch, along Grant 12981 to Manuel S. Novite, Jr. (Lot 4 of Kahakuloa Homesteads, Subdivision of 1938), for the next two (2) courses, the direct azimuths and distances between points on top of said gulch being:

16. 341° 15' 277.83 feet to a pipe and ahu;
17. 70° 30' 611.88 feet to the point of beginning and containing an Area of 78.60 Acres.

Novite, Jr. and Grant 12758 to David Nobriga and Barbara L. E. Nobriga (Lots 4 and 5 of Kahakuloa Homesteads, Subdivision of 1938, respectively), as shown on plan attached hereto and made a part hereof.

Reserving, however, easements for rights-of-way for the existing roads and trails within the above-described Lot 10, as shown on plan attached hereto and made a part hereof.
