Beginning at a 3"x 3" post at the West corner of this lot and the South corner of Lot 10, Block 2, and on the Northeast line of Lindsay Road, the coordinates of said post referred to Government Survey Trig. Station "West Base" being 979.29 feet South and 3127.12 feet West, as shown on Government Survey Registered Map No. 2470, and running by true azimuths:-

1. 233° 30' 99.3 feet along Lot 10, Block 2, to stake;
2. 168° 40' 106.5 feet along Lot 10, Block 2, along fence;
3. 260° 10' 214.7 feet along Lot 10, Block 2, along fence to stake;
4. 233° 30' 163.6 feet along Lot 10, Block 2, to 3"x 3" post;
5. 323° 30' 250.0 feet along Lots 8 and 14, Block 2, to 3"x 3" post;
6. 53° 30' 500.0 feet along Lots 13 and 12, Block 2, to 3"x 3" post;
7. 143° 30' 250.0 feet along the Northeast line of Lindsay Road to the point of beginning.

Excepting and Reserving therefrom L. C. Award 3674 to Barenaba (area 1.25 acres), within this piece, leaving a net area 1.882 ACRES.

Lots 10 and 11, Block 2,
Waimea Homesteads,
Waimea, South Kohala, Hawaii.

Beginning at the West corner of Lot 10 and South corner of Lot 9, Block 2 and on the Northeast side of Lindsay Road, the coordinates of said point referred to Government Survey Trig. Station "West Base" being 743.94 feet South and 3227.02 feet West, as shown on Government Survey Registered Map No. 2470, and running by true azimuths:

1. 235° 09' 500.0 feet along Lot 9, Block 2;
2. 325° 09' 500.0 feet along Lots 8 and 14, Block 2;
3. 55° 09' 500.0 feet along Lots 13 and 12 Block 2;
4. 145° 09' 500.0 feet along Lindsay Road to the point of beginning.

Area 5-799/1000 Acres.

Excepting and Reserving therefrom a right-of-way for a pipe line, said right-of-way being 6 feet wide and 130 feet long.

Also Excepting and Reserving therefrom L.C. Award 3674 Barenaba (area 1.25 acres), within this piece, LEAVING A NET AREA OF 4-489/1000 ACRES.
