LOTS 15 and 15-A

Wailua, Hana (Koolau), Maui, T. H.

Being portions of the Government (Crown) Land of Wailua.

LOT 15 (KULA)-- Beginning at the south corner of this lot, the west corner of Lot 14, Wailua Homesteads, and on the northeast side of a 30-foot road, the approximate coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU ILILUA" being 647.9 feet South and 1202.3 feet East, as shown on Government Survey Registered Map 2234, and running by azimuths measured clockwise from True South:-

1. 141° 13'            155.0 feet along the northeast side of a 30-foot road;
2. 231° 13'            418.0 feet along Grant 4949 to Libert Hubert Boeynaems, Bishop of Zuegma, Vicar Apostolic and Head of the Roman Catholic Church in the Territory of Hawaii;
3. 344° 35'            168.8 feet along L.C.Aw. 4853-G Apana 2 to Kuheleaumoku and Lot 14, Wailua Homesteads;
4. 51° 13'             351.0 feet along Lot 14, Wailua Homesteads to the point of beginning and containing an Area of 1.39 Acres.

LOT 15-A TARO -- Beginning at the west corner of this lot, the north corner of Lot 14-A, and on the south boundary of L.C.Aw. 5060 to Kalawaia, the approximate coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU ILILUA" being 1897 feet South and 87 feet East, as shown on Government Survey Registered Map 2234, and running by azimuths measured clockwise from True South:-

1. 250° 20'            300.0 feet along L.C.Aw. 5060 to Kalawaia;

- 2. 345° 00' 34.9 feet along Grant 10915 to (Mrs.) V.K.W. Young;
- 3. 62° 40' 90.0 feet along Lot 13-A, Wailua Homesteads;
- 4. 343° 00' 60.0 feet along Lot 13-A, Wailua Homesteads;
- 5. 69° 00' 190.0 feet along Lots 13-A and 11-A, Wailua Homesteads;
- 6. 71° 00' 20.0 feet along L.C.Aw. 5058 Apana 1 to Kaulia;
- 7. 163° 00' 111.0 feet along Lot 14-A, Wailua Homesteads, to the point of beginning and containing an Area of 0.60 Acre.

Excepting and reserving therefrom all existing easements and rights in favor of those entitled thereto.
