GRANT

By this its Patent The Government of the Republic of Hawaii makes known to all men, that It has this day granted and given unto William R. Castle-Edward G. Hitchcock & David H. Hitchcock for the consideration of One hundred & thirty Six 70/100(136.70/100) Dollars paid into the Exchequer, all that piece of Land situate at Kaumana Hilo in the Island of Hawaii and described as follows:

Lot No. 16

Beginning at the North west angle of lot 14, coordinates from Halai 14180 S. 22925 W. the boundary runs:

1. South true 1813 feet along lot 14 to post marked ^{XVI}~~XIV~~ at South east angle on canoe road;
2. S. 78° 38' W. true 285 feet along old canoe road, the boundary between Kaumana and Kukuau 2nd;
3. S. 61° 37' W. true 235 feet along same;
4. S. 59° 18' W. true 148 feet along same;
5. N. 87° 38' W. true 316 feet along same;
6. S. 78° 57' W. true 364 feet along same;
7. S. 83° 32' W. true 295 feet along same to pile of stones marked XVI on the lava flow;
8. N. 19° 10' E. true 1540 feet to a pile of stones marked XVI on the lava flow;
9. N. 57° 35' E. true 1289 feet along lava flow to the initial point.

Beginning at a pile of stones marked XXIII at the North west angle coordinates from Halai 17120 S. 35710 W. from which point the Haw'n Gov't Survey Δ 2nd Sta. Waihimaunalua bears true distant feet the boundary runs.

1. S. 87° 33' E. true 2582 feet along South branch of flow to pile of stones marked XXIII;
2. N. 73° 38' E. true 1198 feet along same to pile of stones marked XXIII;
3. S. 76° 35' E. true 1988 feet along same to pile of stones marked XXIII;
4. South true 300 feet along same to pile of stones marked XXIII at edge; of flow;

5. S. 32° 36' W. true 1455 feet in woods on boundary of Kaumana & Kukuau 2nd;
6. N. 82° 22' W. true 824 feet along the same;
7. S. 55° 24' W. true 915 feet along the same;
8. N. 72° 54' W. true 585 feet along the same;
9. N. 49° 47' W. true 2026 feet along the same;
10. N. 81° 7' W. true 1662 feet along the same to pile of stones marked XXIII on lava flow;
11. N. 46° 20' E. true 624 feet along lava flow to the initial point.

excepting and reserving to the Hawaiian Government all mineral or
metallic mines of every description.
