Beginning at a 1-1/2" galvanized iron pipe at the head of the Alenaio Gulch on the South side of this lot, the coordinates of said point of beginning referred to Government Survey Trig. Station "Haiku" being 4002.9 feet South and 596.5 feet East, as shown on Government Survey Registered Map NO. 2568 and running by true azimuths:-

1. 85° 18' 30" 439.5 feet along 40 foot road to a pipe;
2. 85° 18' 40.2 feet across Piha road and along 40 foot road to a pipe;
3. 86° 50' 31.5 feet across 30 foot road and along 40 foot road to a pipe;
4. 88° 23' 295.1 feet along 40 foot Kahuku-Piha Road to a pipe;
5. 197° 18' 424.5 feet along lot 15/16 to a pipe on the West side of a 30 foot road;
6. 205° 09' 38.0 feet across 30 foot road to a pipe;
7. 153° 04' 664.5 feet along 30 foot road to a pipe on the South side of lot 17;
8. 222° 57' 300.5 feet along lot 17 to a pipe;
9. 214° 59' 452.9 feet along Lot 17 to a pipe on the West side of Lot 20/22;
10. 315° 34' 447.0 feet along Lot 20/22 to a pipe on the North side of Lot 21/23;

11. $45^{\circ} 35'$ 144.9 feet along lot 21/23 to a pipe at the Northwest corner of lot 21/23;
12. $315^{\circ} 34'$ 603.6 feet along lot 21/23 to a pipe on the South side of the Piha road;
13. $315^{\circ} 34'$ 291.0 feet along lot 21/23 to a pipe in the center of Alenaio Gulch;
14. $357^{\circ} 06'$ 297.2 feet along the center of Alenaio Gulch to a pipe;
15. $66^{\circ} 55'$ 262.0 feet along the center of Alenaio Gulch to a pipe;
16. $43^{\circ} 42'$ 160.0 feet along the center of Alenaio Gulch to the point of beginning;

Containing an area of 28-26/100 Acres.

Excepting and reserving therefrom a strip of land 30 feet wide for a public road, said road strip containing an area of 1.02 Acre. Also excepting and reserving therefrom a right-of-way 10 feet wide for the flume across this lot, said right-of-way containing an area of 7/100 acre; and also excepting and reserving therefrom the streams and all riparian and other rights in or to these streams and the waters thereof; LEAVING A NET AREA OF 27-17/100 ACRES.
