Beginning at a $1\frac{1}{2}$ inch galvanized iron pipe at the East corner of this lot, the South corner of Lot 198, on the West side of Hauaala Road, the coordinates of said point of beginning referred to Government Survey Trig. Station "Nonou" being 11779.5 feet North and 13566.8 feet East, as shown on Government Survey Registered Map No. 2583, and running by true azimuths:-

1. $18^{\circ} 29'$ 69.3 feet along Hauaala Road to a $1\frac{1}{2}$ inch galv. iron pipe;
2. $48^{\circ} 20'$ 66.1 feet along Hauaala Road to a $1\frac{1}{2}$ inch galv. iron pipe;
3. $71^{\circ} 27'$ 214.5 feet along Hauaala Road to a $1\frac{1}{2}$ inch galv. iron pipe;
4. $53^{\circ} 46'$ 201.0 feet along Hauaala Road to a $1\frac{1}{2}$ inch galv. iron pipe;
5. $6^{\circ} 48'$ 316.0 feet along Hauaala Road to a $1\frac{1}{2}$ inch galv. iron pipe;
6. $117^{\circ} 34'$ 952.7 feet along Kawaihau Road to a $1\frac{1}{2}$ inch galv. iron pipe;
7. $204^{\circ} 14'$ 697.7 feet along Lot 195 to a $1\frac{1}{2}$ inch galv. iron pipe;
8. $294^{\circ} 14'$ 1133.6 feet along Lots 197 and 198 to point of beginning.

Area 16-09/100 Acres.

1. Excepting and reserving the right to the present public road as shown on the plan hereto attached and made a part hereof, until such time said public road is abandoned.

2. Excepting and reserving therefrom a rights-of-way 10 feet wide for the ditches across this lot; said rights-of-way containing an area of 29/100 acre; LEAVING A NET AREA OF 15-80/100 ACRES.
