PART A. Being a portion of the Land of Lalamilo, an Ili of the Government (Crown) Land of Waimea

Beginning at a pipe at the west corner of this parcel of land and the north corner of Part A of Lot 22 of Lalamilo Farm Lots, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU PA" being 8236.58 feet North and 3384.71 feet East, as shown on Government Survey Registered Map H.S.S. Plat 420, thence running by azimuths measured clockwise from True South:-

1. 216° 30' 96.85 feet along Government Land;
2. 4° 47' 10" 113.85 feet along Part B hereinbelow described;
3. 126° 30' 59.85 feet along Part A of Lot 22 of Lalamilo Farm Lots to the point of beginning and containing an Area of 0.066 Acre.

PART B. Being a portion of Grant 1157 to George W. Macy and James Louzada conveyed to the Territory of Hawaii by Richard Smart by Deed dated June 12, 1956 and recorded in Liber 3126 Pages 36-55 (Land Office Deed 13596).
