15. 345° 12' 120.9 feet along top of West edge of Pahale gulch;
16. 13° 26' 104.0 feet along top of West edge of Pahale gulch;
17. 85° 32' 154.6 feet along top of West edge of Pahale gulch;
18. 67° 08' 156.3 feet along top of West edge of Pahale gulch;
19. 46° 43' 66.9 feet along top of West edge of Pahale gulch to a
2½ inch galvanized iron pipe;
20. 131° 15' 490.1 feet along Lot 40 to the point of beginning.
