Station "Puolo" being 19744.3 feet North and 16861.3 feet East, as shown on Government Survey Registered Map No. 2619, and running by true azimuths:-

1. $288^{\circ} 00'$ 140.0 feet along government land to near West bank of Hanapepe River;
2. $10^{\circ} 30'$ 440.0 feet along near the West bank of the Hanapepe River;
3. $21^{\circ} 30'$ 230.0 feet along same;
4. $32^{\circ} 00'$ 320.0 feet along fence near West bank of Hanapepe River;
5. $13^{\circ} 00'$ 500.0 feet along same;
6. $340^{\circ} 00'$ 20.0 feet along near West bank of Hanapepe River to West side of ditch;
7. $17^{\circ} 00'$ 400.0 feet along West side of ditch;
8. $00^{\circ} 20'$ 65.0 feet along near the West bank of Hanapepe River;
9. $24^{\circ} 00'$ 510.0 feet along same;
10. $106^{\circ} 00'$ 107.0 feet along government land to the trail at foot of pali;
11. $182^{\circ} 50'$ 280.0 feet along the trail at foot of pali;
