Lot 47. Beginning at an ohia post at the East corner of this lot, the West corner of Government Main Road and Kuhiwa Branch Road, the approximate coordinates of said point of beginning referred to Government Survey Trig. Station "Puu Hinai" being 8000 feet North and 12200 feet West, as shown on Government Survey Registered Map No. 2649, and running by true azimuths:-

1. 52° 10' 96.0 feet along Kuhiwa Branch Road (30 feet wide);
2. 65° 30' 291.0 feet along same;
3. 39° 56' 76.0 feet along same;
4. 130° 42' 405.0 feet along Lot 48, and from said point, the direct azimuth and distance to Trig. Station "Apana" being: 223° 24' 365.0 feet;
5. Thence along East edge of the Makapipi Gulch, the direct azimuth and distance being: 199° 53' 384.4 feet, and from said point the direct azimuth and distance to Trig. Station "Apana" being: 304° 22' 159.0 feet;

Lot 48. Beginning at an ohia post at the North corner of this lot, the West corner of Lot 47 and on the East edge of the Makapipi Gulch, the direct azimuth and distance to Trig. Station "Apana" being 223° 24' 365.0 feet, and the approximate coordinates of said point of beginning referred to Government Survey Trig. Station "Puu Hinai" being 8280 feet North and 12640 feet West, as shown on Government Survey Registered Map No. 2649, and running by true azimuths:-

1. 310° 42' 405.0 feet along Lot 47 to an ohia post on West edge of Kuhiwa Branch Road; (30 feet wide);
2. 34° 08' 218.0 feet along Kuhiwa Branch Road;

Makapipi Gulch, the approximate coordinates of said point of beginning referred to Government Survey Trig. Station "Puu Hinai" being 7180 feet North and 13550 feet West, as shown on Government Survey Registered Map No. 2649, and running by true azimuths:-

1. 312° 07' 501.0 feet along Lot 48;
2. Thence along West edge of the Kuhiwa Branch Road (30 feet wide), said road being along the West side of Kuhiwa Gulch, the direct azimuth and distance being: 2° 08" 695.3 feet;
3. 138° 07' 1015.0 feet along Lot 27 (Grant 4378 to Nahiku Rubber Co) to an ohia post;
4. Thence along East side of the Makapipi Gulch, the direct azimuth and distance being: 230° 20' 431.0 feet to the point of beginning.
