Beginning at a + on stone at the Northeast corner of this lot at an angle on the West side of homestead road 40 feet North of a bridge, from which point the true azimuth and distance to Trig. Station "Puhala Pipe" is  $255^{\circ} 32'$  1715.8 feet, and the coordinates of said point of beginning referred to Government Survey Trig. Station "Kalusamoa" are 86.0 feet South and 3079.0 feet West, as shown on Government Survey Registered Map No. 2493, and running by true azimuths:-

1.  $20^{\circ} 28'$  355.9 feet along West side of homestead road across a ditch to a + on stone;
2.  $297^{\circ} 30'$  82.35 feet along West side of homestead road to a + on stone;
3.  $353^{\circ} 48'$  263.0 feet along West side of homestead road to a + on stone on the North side of 30 foot road;
4.  $119^{\circ} 36'$  98.96 feet along North side of 30 foot road to a + on stone; ~~on the East bank of stream;~~
5.  $162^{\circ} 45'$  48.9 feet; ~~along bank of stream to a point~~
6.  $117^{\circ} 41'$  197.6 feet; ~~along bank of stream to a point~~
7.  $138^{\circ} 49'$  350.1 feet; ~~along bank of stream to a point~~
8.  $264^{\circ} 31'$  114.0 feet; ~~along bank of stream to a point~~
9.  $276^{\circ} 11'$  211.9 feet; ~~along bank of stream to a point~~

10. 206° 49' 214.6 feet ~~along bank of stream~~ to a + on stone;

11. 269° 17' 109.2 feet along Lot 47A across a ditch to the point of beginning.

Area 3-02/100 Acres.

Excepting and Reserving therefrom a right-of-way 15 feet wide across this lot for the ditch, said right-of-way containing an area of 01/100 Acre, LEAVING A NET AREA OF 3-01/100 ACRES.
