
Beginning at an iron pipe at the Southeast corner of this Lot and on the West side of Government Main Road, the coordinates of said point referred to Government Survey Trig. Station "Coolidge" being 449.3 feet South and 3277.0 feet East, as shown on Government Survey Registered Map No. 2562, and running by true azimuths:-

1. 70° 00' 270.0 feet along Lot 3 to an iron pipe;
2. 160° 00' 299.3 feet along Lot 2 to an iron pipe;
3. 235° 00' 51.6 feet along Pratt Road to a + on stone;
4. 225° 00' 69.3 feet along Pratt Road to a + on stone;
5. 239° 40' 323.7 feet along Pratt Road to an iron pipe;
6. 352° 15' 125.3 feet along Government Main Road to an iron pipe;
7. 357° 58' 119.5 feet along Government Main Road to an iron pipe;
8. 8° 28' 100.0 feet along Government Main Road to an iron pipe;
9. 13° 15' 91.0 feet along Government Main Road to the point of beginning.
