Being portion of Grant 10417 to Waiakea Mill Company conveyed to the Territory of Hawaii by W. H. Hill, by deed dated August 23, 1948 and recorded in Book 2161, Pages 321-341 (Land Office Deed 8510).

Beginning at the southwest corner of Lot 1, and at the northeast corner of Ainaola Drive and Road 6 West, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 18505.8 feet South and 2967.3 feet West, as shown on Government Survey Registered Map 2650, thence running by azimuths measured clockwise from True South:

1. 175° 40'                      99.17 feet along the east side of Road 6 West;
2. 265° 40'                      121.00 feet along Grant 11698 to Shinichi Ikawa  
(Lot 3, Camp 6 House Lots);
3. 355° 40'                      96.38 feet along Grant 11702 to (Miss) Nit Lin  
Lau (Lot 9, Camp 6 House Lots) and  
Grant 11726 to Toshio Matsumoto and  
Tamako Matsumoto (Lot 10, Camp 6  
House Lots);
4. 89° 02'                        32.59 feet along the north side of Ainaola Drive;
5. 82° 37' 30"                    88.60 feet along the north side of Ainaola Drive  
to the point of beginning and contain-  
ing an Area of 11670 Square Feet.
