LOT 3, PARTS 1 and 2

PILIAMOO, MOILIILI, HONOLULU, OAHU, T. H.

LOT 3, PART 1--Being a portion of the Government (Crown) Land of Piliamoo.

Beginning at the west corner of this parcel of land, the north corner of Part 1 of Lot 4 of Piliamoo House Lots, and on the southeast side of Kalei Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "KAMOILIILI" being 502.06 feet North and 1310.60 feet East, as shown on Government Survey Registered Map 2878, thence running by azimuths measured clockwise from True South:-

1. 227° 23' 81.67 feet along the southeast side of Kalei Road to a pipe;
2. 220° 45' 22.32 feet along the southeast side of Kalei Road to an iron pin;
3. 308° 30' 98.94 feet along Part 1 of Lot 2 of Piliamoo House Lots;
4. 48° 00' 40.42 feet along Part 2 of Lot 3 of Piliamoo House Lots;
5. 327° 00' 31.51 feet along Part 2 of Lot 3 of Piliamoo House Lots;
6. 31° 30' 53.52 feet along the northwest side of the North Branch of Manoa-Palolo Drainage Canal;
7. 128° 30' 142.17 feet along Part 1 of Lot 4 of Piliamoo House Lots to the point of beginning and containing an Area of 12,136 Square Feet.

Subject, however, to a Sanitary Sewer Easement in favor of the City and County of Honolulu over, under and across the above-described parcel of land as shown on plan attached hereto and made a part hereof and more particularly described as follows:

Beginning at the south corner of this Easement, the east corner of Part 1 of Lot 4 of Piliamoo House Lots, on the northwest side of the North Branch of Manoa-Palolo Drainage Canal, and at the end of Course 6 of the above-described parcel of land, thence running by azimuths measured clockwise from True South:-

1. 128° 30' 10.08 feet along Part 1 of Lot 4 of Piliamoo House Lots;
2. 211° 30' 57.06 feet;
3. 327° 00' 11.08 feet along Part 2 of Lot 3 of Piliamoo House Lots;
4. 31° 30' 53.52 feet along the northwest side of the North Branch of Manoa-Palolo Drainage Canal to the point of beginning and containing an Area of 553 Square Feet.

LOT 3, PART 2--Being a portion of R.P. 7399 L.C.Aw. 1627, Apana 3 to Keonea, covered by Deed of Trustees of B.P. Bishop Estate to Territory of Hawaii, dated January 30, 1917 and recorded in Book 465, Pages 25-30 (Land Office Deed 1801)

Beginning at the east corner of this parcel of land, the south corner of Part 3 of Lot 2 of Piliamoo House Lots, and on the northwest side of the North Branch of Manoa-Palolo Drainage Canal, the coordinates of said point of beginning referred to Government Survey Triangulation Station "KAMOILILI" being 502.03 feet North and 1476.07 feet East, as shown on Government Survey Registered Map 2878, thence running by azimuths measured clockwise from True South:-

1. 31° 30' 50.24 feet along the northwest side of the North Branch of Manoa-Palolo Drainage Canal;
2. 147° 00' 31.51 feet along Part 1 of Lot 3 of Piliamoo House Lots;
3. 228° 00' 40.42 feet along Part 1 of Lot 3 of Piliamoo House Lots;
4. 308° 30' 17.09 feet along Part 3 of Lot 2 of Piliamoo House Lots to the point of beginning and containing an Area of 1055 Square Feet.

Subject, however, to a Sanitary Sewer Easement in favor of the City and County of Honolulu over, under and across the above-described parcel of land as shown on plan attached hereto and made a part hereof and more particularly described as follows:

Beginning at the east corner of this Easement, the south corner of Part 3 of Lot 2 of Piliamoo House Lots, on the northwest side of the North Branch of Manoa-Palolo Drainage Canal, and at the initial point of the above-described parcel of land, thence running by azimuths measured clockwise from True South:-

1. 31° 30' 50.24 feet along the northwest side of the North Branch of Manoa-Palolo Drainage Canal;

- 2. 147° 00' 11.08 feet along Part 1 of Lot 3 of Piliamoo House Lots;
- 3. 211° 30' 46.70 feet;
- 4. 308° 30' 10.08 feet along Part 3 of Lot 2 of Piliamoo House Lots to the point of beginning and containing an Area of 485 Square Feet.
