Koolauloa, Oahu.

Beginning at a post on the boundary between Paumalu and Kaunala at the North corner of this lot and the East corner of Lot 1, the true azimuth to Government Survey Trig. Station "Waialeale" being: $208^{\circ} 14' 30''$ and the coordinates of said initial point referred to Government Survey Trig. Station "Pupukea" being: 4516.0 feet North and 5788.0 feet East, as shown on Government Survey Registered Map No. 2252, and running by true azimuths:-

1. $323^{\circ} 43' 30''$ 1534.0 feet along Kaunala to post by small rise;
2. $308^{\circ} 05' 30''$ 2184.6 feet along Kaunala to post on small rise on the East side of large hollow, the azimuth to "Waialeale" Trig. Station being: $179^{\circ} 15'$;
3. $42^{\circ} 00'$ 2346.0 feet along Lots 23 and 22 to point on ridge between Aimuu and Paumalu Gulches;
4. $153^{\circ} 50'$ 1077.0 feet along down ridge;
5. $114^{\circ} 00'$ 1470.0 feet along down ridge to point in gulch;
6. $131^{\circ} 08'$ 1060.0 feet down Paumalu Gulch to post on North bank of stream at the East corner of Lot 5;
7. $217^{\circ} 01' 30''$ 2588.0 feet along Lots 2 and 1 to the point of beginning

Area 180.7 Acres.

Excepting and Reserving therefrom a strip of land 14 feet wide across this lot for a public road, said road strip containing an area of 1.28 acres, the center line of which is more particularly described as follows:-

Beginning at a point in center of road on the Northwest line of Lot 6 to F.A.Lyman at the South corner of Lot 1 to Ada T. Gibson and the East corner of Lot 2 to Herbert Stocks, as shown on Government Survey Registered Map No. 2252, and running by true azimuths:-

1. 288° 20' 215.0 feet along line 7 feet from fence;
2. 294° 48' 1444.0 feet along line 7 feet from fence;
3. 278° 00' 220.0 feet along line 7 feet from fence;
4. 235° 05' 275.5 feet along line 7 feet Northwest of fence to the Kaunala boundary, the true azimuth and distance from this point to a post at angle on the Northeast line of Lot 6 and Kaunala being: 128° 05' 30" 436.5 feet;
5. 55° 05' 19.0 feet along line 7 feet Northwest of fence;
6. 308° 05' 30" 582.0 feet along line 19 feet Southwest of fence;
7. 328° 35' 450.0 feet along line West of fence;
8. 312° 42' 737.0 feet along line West of fence to a point in Mrs. Rose May Wheeler's gateway 7 feet from Northwest gate post, the true azimuth and distance from this point to the North corner of Lot 23 being: 222° 00' 242.7 feet.
