Being a portion of L.P. 8165, Part B, on a portion of L.C.Aw. 8559-B Apana 32 to William C. Lunalilo

Being also portion of the land conveyed to the Minister of Interior by the Trustees of William C. Lunalilo Estate by Deed dated June 17, 1884, and recorded in Liber 88 in Pages 223 and 224 (Land Office Deed 136), set aside as Fort Ruger Military Reservation, Tract 1, by Presidential Executive Order 6408, dated November 7, 1933 and subsequently restored to the possession, use and control of the Territory of Hawaii by Presidential Executive Order 10648 (Parcel 1) dated December 8, 1955.

Beginning at the south corner of this lot, the east corner of Lot 77, Diamond Head View Lots, Unit One, and on the west side of Hakaka Place, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LEAHI" being 1021.14 feet North and 6667.91 feet East, as shown on Government Survey Registered Map 4090, thence running by azimuths measured clockwise from True South:-

1. 108° 30' 6.00 feet along Lot 77, Diamond Head View Lots, Unit One;
2. 198° 30' 6.00 feet along Lot 78-A, Diamond Head View Lots, Unit One;
3. 288° 30' 6.00 feet along Lot 78-A, Diamond Head View Lots, Unit One;
4. 18° 30' 6.00 feet along the west side of Hakaka Place to the point of beginning and containing an Area of 36 Square Feet.
