Station "Salt Lake" being 9731.3 feet North and 1844.9 feet West, as shown on Government Survey Registered Map No. 2536, and running by true azimuths:-

1. 146° 05' 296.5 feet along Lots 26 and 27, to a stake;
2. 220° 24' 20.8 feet across road to a stake;
3. 146° 05' 332.5 feet along the Northeast side of a 20 Foot Road, to a stake;
4. 236° 05' 425.0 feet along Lot 18, to a stake;
5. 326° 05' 416.9 feet along Lot 17, to a stake;
