Beginning at the southwest corner of this lot, the southeast corner of Lot 56-A, Camp 6 House Lots, and on the north side of Ainaola Drive, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 18,671.87 feet South and 1700.25 feet West, as shown on Government Survey Registered Map 2650, thence running by azimuths measured clockwise from True South:-

2. 265° 40'                    111.90 feet along Grant 10543 to Shinkichi Higa  
(Lot 1003, Waiakea Homesteads 2nd Series);
3. 355° 40'                    205.69 feet along Lot 57, Camp 6 House Lots;
4. 100° 36'                    115.82 feet along the north side of Ainaola Drive  
to the point of beginning and contain-  
ing an Area of 21,347 Square Feet.
