to Hideo Nakasone

Being also a portion of the Government (Crown) Land of Waiakea

Beginning at the northeast corner of this parcel of land, the
northwest corner of Grant 12229 to Harry Chun Akana and Amy K. Chun Akana,
and on the west side of Iwalani Street, the coordinates of said point of
beginning referred to Government Survey Triangulation Station "HALAI"
being 12069.02 feet South and 5521.60 feet East, as shown on Government
Survey Registered Map 2600, thence running by azimuths measured clock-
wise from True South:-

- 1. 355° 40' 20.46 feet along the west side of Iwalani Street;
