Being a portion of the Government (Crown) Land of Waiakea

Beginning at the southwest corner of this lot, the southeast corner of Lot 910-A, Waiakea Homesteads 1st Series, and on the north boundary of Grant 8642 to Rosaline T. Ferreira (Lot 912, Waiakea Homesteads 1st Series), the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 17532.7 feet South and 4256.7 feet East, as shown on Government Survey Registered Map 2600, thence running by azimuths measured clockwise from True South:-

1. 175° 40' 1800.0 feet along Lot 910-A, Waiakea Homesteads 1st Series;
2. 265° 40' 484.0 feet along the south side of Haihai Street to an iron pipe;
3. 355° 40' 1800.0 feet along Grant 11261 to (Mrs.) Adelida G. Camacho (Lot 908, Waiakea Homesteads 1st Series) to an iron pipe;
4. 85° 40' 484.0 feet along Grant 8642 to Rosaline T. Ferreira (Lot 912, Waiakea Homesteads 1st Series) to the point of beginning and containing an Area of 20.00 Acres.
