
Being a portion of the Government (Crown) Land of Waiakea

Beginning at an iron pipe at the southeast corner of this lot, the southwest corner of Lot 910-A, Waiakea Homesteads 1st Series, and on the north boundary of Grant 8642 to Rosaline T. Ferreira (Lot 912, Waiakea Homesteads 1st Series), the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 17569.3 feet South and 3774.1 feet East, as shown on Government Survey Registered Map 2600, thence running by azimuths measured clockwise from True South:-

1. 85° 40' 484.0 feet along Grant 8642 to Rosaline T. Ferreira (Lot 912, Waiakea Homesteads 1st Series);
2. 175° 40' 1800.0 feet along Lot 911-A, Waiakea Homesteads 1st Series;
3. 265° 40' 484.0 feet along the south side of Haihai Street to an iron pipe;
4. 355° 40' 1800.0 feet along Lot 910-A, Waiakea Homesteads 1st Series, to the point of beginning and containing an Area of 20.00 Acres.
