4. 85° 40' 361.2 feet along Lot 1008 2nd. Series to an iron bolt;
5. 355° 40' 739.2 feet along same to an iron bolt;
6. 85° 40' 1200.1 feet along Lot 1009 2nd. Series to the point of beginning.

Gentlemen:

We submit herewith white print whereon is shown in red a 20-foot strip along the east side of Lot 1009, Waiakea Homestead Cane Lots adjoining the west side of Lot 1008, which has been withdrawn from the operation of General Lease 2629 to Waiakea Mill Company, to serve as a road for access to Lot 921, Waiakea Homestead Cane Lots, covered by Grant 9495 to William G. Aiona from Road A, in lieu of the road shown on the enclosed plan in yellow originally provided to serve Lot 921, which road shown in yellow, has never been built.

Please make the necessary changes in your records to show the new road reserve for Lot 921 through Lot 1009, as shown in red on the enclosed plan.
