## CANDIDATE COMMITTEE NOTICE OF INTENT TO HOLD A FUNDRAISER

Under Hawaii Revised Statutes §11-342, no fundraiser shall be held unless a notice of intent to hold the fundraiser is filed with the Campaign Spending Commission ("Commission") for which the price or suggested contribution for attending the fundraiser is <u>more than \$25 per person</u>. The person in charge of the fundraiser shall file the notice with the Commission prior to the fundraiser.
