(This is the first election-year report for candidates whose names did not appear on the Primary Election ballot but will appear on the General Election ballot.)

2nd Preliminary General

Late Contributions

(A candidate or candidate committee that receives contributions from any person aggregating more than \$500 within the period of fourteen calendar days through four calendar days prior to the General Election shall file a Late Contributions Report. The report is not required if the candidate is not on the General Election ballot or if there are no late contributions. Note: Late contributions will also be reported on the Final Election Period Report.)

FOR THE KAUAI MAYOR CANDIDATE ELECTED TO OFFICE

Pursuant to Act 97, signed into law on July 5, 2017, a candidate who is elected and is to be sworn into office prior to thirty days after the general election in which the candidate was elected, shall file the Final Election Period Report three business days before the date the candidate is to be sworn into office. The Kauai Mayor will be sworn in on December 1, 2026.

Expenditures of Public Funds

(Required by candidates who received public funds for the General Election.)

December 3, 2026

Application For Public Funds

ALERT

At the conclusion of the General Election on November 3, 2026, candidate committees still registered with the Campaign Spending Commission ("Commission") must continue to electronically file reports in the Candidate Filing System until their final disclosure report has no surplus or deficit, and a request to terminate is submitted to and approved by the Commission. The first report due after the General Election is the Supplemental Report covering the reporting period of November 4 through December 31, 2026. This report is due on February 1, 2027.
