(For candidates that won in the Primary Election and advanced to the General Election. This report is not required for candidates that lost or were elected to office in the Primary Election. See the Final Election Period Report.)
- or**
- October 1, 2026 January 1-September 26, 2026 1st Preliminary General
(This is the first election-year report for candidates whose names did not appear on the Primary Election ballot but will appear on the General Election ballot.)
- October 26, 2026 September 27-October 19, 2026 2nd Preliminary General
- November 2, 2026 October 20-October 30, 2026 Late Contributions
(A candidate or candidate committee that receives contributions from any person aggregating more than \$500 within the period of fourteen calendar days through four calendar days prior to the General Election shall file a Late Contributions Report. The report is not required if the candidate is not on the General Election ballot or if there are no late contributions. Note: Late contributions will also be reported on the Final Election Period Report.)

FOR THE KAUAI COUNTY COUNCIL CANDIDATES ELECTED TO OFFICE

Pursuant to Act 97, signed into law on July 5, 2017, a candidate who is elected and is to be sworn into office prior to thirty days after the general election in which the candidate was elected, shall file the Final Election Period Report three business days before the date the candidate is to be sworn into office. The Kauai Mayor will be sworn in on December 1, 2026.

(For the Kauai County Council candidates elected to office in the General Election.)
- December 3, 2026 October 20-November 3, 2026 Final Election Period
(For candidates required to file 1st and 2nd Preliminary General reports.)
- or**
- December 3, 2026 August 9-November 3, 2026 Final Election Period
(For candidates that lost or were elected to office in the Primary Election and who did not appear on the General Election ballot.)
- or**
- December 3, 2026 January 1-November 3, 2026 Final Election Period
(For candidate committees who filed the Organizational Report by the June 30, 2026 deadline stating their intent to not receive contributions, or make expenditures, that aggregate more than \$1,000 in the 2026 election period.)
- December 3, 2026 January 1-November 3, 2026 Expenditures of Public Funds
(Required by candidates who received public funds for the General Election.)
- December 3, 2026 LAST DAY TO APPLY Application For Public Funds

ALERT

At the conclusion of the General Election on November 3, 2026, candidate committees still registered with the Campaign Spending Commission (“Commission”) must continue to electronically file reports in the Candidate Filing System until their final disclosure report has no surplus or deficit, and a request to terminate is submitted to and approved by the Commission. The first report due after the General Election is the Supplemental Report covering the reporting period of November 4 through December 31, 2026. This report is due on February 1, 2027.
