
Payroll Beneficiary Query

Beneficiary Designation Navigation:

- Workforce Administration > Personal Information > Personal Relationships > Beneficiary Designation
- 1. A new query is available to allow you to view the employees that have designated a beneficiary within HIP
 - Query Name: M_BENEF_DESIGN_QRY
- 2. A 2nd query is available to show all active employees that have NOT designated a beneficiary within HIP
 - Query Name: M_BENEF_NODESIGN_QRY

Beneficiary Enrollment Update

- As of today 11/18/19
- Number of Employees who have enrolled a beneficiary: 4,455
- Total number of beneficiaries that have been enrolled: 6,661



Pay Statement View

- The HIP Pay Statement will be updated to reflect additional information for our employees.
- Currently employees with the Employee Type of Salaried or Exception Hourly,
 do not see the Hours and Rate on earnings that are entered in the online PCS
- Soon these employees will now see these details with their State of Hawaii Pay Statement
- Employee's being paid an Amount only, will only see the amount under Earnings as they do today



ERS Reporting and Adjustments

- As a reminder, all payroll transactions are reported to ERS each pay period, which also includes off-cycles and payroll corrections.
- For example, if an employee was paid in error and we cancel the check, the payment is reversed from ERS through a payroll file.
- You should not complete the payroll adjustment template as it would result in a duplicate adjustment.
- As ERS adjustments also likely include adjustments to the employees pay for W-2 reporting purposes, once it is updated in HIP, it is provided to ERS.

Tip: How Depts can tell when a check has been reversed

- When you need to confirm a paycheck has been reversed by Central Payroll.
- Payroll for North America> Payroll Processing USA>Produce Payroll>Review Paycheck.
- Search by the Employee ID number. Find the issued check that was recalled. You will see the Paycheck Option show <u>Check Reversal</u>



What is the time frame when an employee transfers to another department with their records?

- When an employee transfers to another department, once the entry is completed in HIP and "Saved" under the HR record (Job Data), then the new department is able to process payroll information for that employee.
- Executive Branch (Company = SOH) uses HIP as their HR system of record and transfer electronic HR records using the same employee record within Job Data
 - Since this process involves multiple departments, it may take longer for HR to have the entry completed.
- All other agencies use their own employee records and are able to complete transfers on their own.

Child Support New Hire Reporting

- With the W-4/HW-4 forms being available in HIP electronically, we have received a number of questions about the New Hire reporting required by Hawaii Child Support.
- Please note that all Executive Branch agencies that use HIP as their HR System of Record (Company = SOH) are reported electronically each pay period. Paper forms should not be provided separately
- We are working with other jurisdictions that would like to be included in this reporting and will notify you individually when requested and completed.

HIP New Hire Letter

- The HIP New Hire Letter has been updated to account for recent HIP changes, such as the Beneficiary Designation and Tax Withholding Updates.
- Please note that all New Hires should be provided this letter by their HR office to provide their login credentials as well as to provide the information that needs their attention within HIP.
- Payroll should not be entering W-4/HW-4 withholding forms for employees unless an accommodation is needed for an employee.

Year End Updates

- 1. Only four more off-cycles remain for calendar year 2019;
 - 11/18/2019, 11/22/2019, 12/02/2019, and 12/09/2019.
- 2. Only two more on-cycles remain for calendar year 2019;
 - 12/05/2019 and 12/20/2019.
- 3. SSN Name and Number errors must be resolved as soon as possible. If a department continues to use the incorrect information while trying to pay an employee, Central Payroll may elect to not pay this employee until this error is resolved. Any SSN corrections that are not resolved prior to 12/23/19 will need to be handled with a W-2 Correction

Year End Updates

4. W-2 Issuance:

- A. W-2 Electronic Consent Continue to encourage your employees to use HIP ESS to enroll in W-2 electronic consent to receive their W-2 online only before it is available on paper.
 - Query to see employee status is available: M_W2_CONSENTS
- B. Change in Address –
 The absolute last day to update addresses for W2 purposes will be 12/31/2019. This will guarantee that it is updated in time for the issuance of the W2 form.
- C. Terminated Employees Employees would automatically get a paper W2.


- New HIP Service Center Hours of Operation:
