- 1. Timothy Hiu convened the meeting at 9:05a.m.
- 2. The minutes from the July 22, 2008 meeting were reviewed and approved subject to the following revisions:
 - Item no. 4 change second paragraph DCAB change to Department of Justice
 - b. Item no. 4 change third paragraph to note accepted amendments were "as submitted by Ralph Nagamine (which is part of these minutes)"
 - c. Item no. 7 should be Gary Chock instead of Ralph Nagamine.
- 3. There was no public comment.
- Council reviewed Chapter 15-110 of the County of Maui rules related to Indigenous Hawaiian Architecture Structures with the following amendments.
 - a. Add to the the definition of Certified hale builder on page 110-4, "or approved by the county building official".
 - b. Add to 110-5, item 7d, "approved" before battery.
 - c. Delete from 110-7 item c, "title 11, chapter 12, of"
 - d. Delete from 110-7 entire item d
 - e. Delete the entire subchapter 3
 - f. Delete from 110-15 item c, the word "mechanical" before engineer
 - g. Delete from 116-16 item a2, "exposure B and:
 - h. Delete the entire subchapter 5
 - i. This section will be incorporated as appendix X. The revised version of will be sent to the IBC and structural investigative committees for review before adoption.

- 5. The committee agreed that after Appendix X is completed, it will be sent to the IBC and Structural investigative committees to be reviewed.
- 6. Review of the amendments in the July 22 edition of the Draft Amendments to the IBC resulted in the following decisions.
 - a. Section 1603.1, changes not adopted
 - b. Section 1603.1.1, changes not adopted, section will be included in Appendix W
 - c. Section 1603.3 changes adopted
 - d. Section 1613.5.6 changes to Tables (1) and (2) adopted
 - e. Section 1702, question arose as to the need for the proposed amendment. Gary Chock noted that the amendment was needed to eliminate confusion with HRS 464. The committee after discussion decided that it wanted the Attorney General's office (AG) to review the IBC section 1702 and the HRS 464 to determine if there was a conflict before making a decision on the amendment.
 - f. Section 1704.1 State agencies should not be exempt from special inspection requirement. Decision on this section will be contingent on response from AG.
 - g. For sections 1702 and 1704.1, Gary Chock will email position to Tim Hiu with IBC and HRS documents and Tim will send to Kerry with his comments to be forwarded to the AG for review.
 - h. Ralph Nagamine's amendment to section 1704.1 is deferred pending response from AG
 - i. Section 1805, defer decision on tables
 - j. Section 1808.2.7, amendment adopted
 - k. Section 2104.1.9, amendment adopted
 - I. Section 2304.11.2, deferred until next meeting, Doug Haigh will propose language
 - m. Section 2303.1.8 amendments all approved
 - n. Section 2304.9.5 amendment approved
