KAPAA, KAWAIIHAU (PUNA), KAUAI, T. H.

Being portion of the Government (Crown) Land of Kapaa.

Beginning at a 3/4-inch pipe at the north corner of this lot, the east corner of Lot 1, Kapahi Farm Lots, and on the west side of Kaapuni Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "NONOU" being 13207.41 feet North and 2961.48 feet East, as shown on Government Survey Registered Map 4075, thence running by azimuths measured clockwise from True South:

1. 340° 46' 417.74 feet along the west side of Kaapuni Road to a 3/4-inch pipe;
2. Thence along the west side of Kaapuni Road, on a curve to the left having a radius of 415.00 feet, the chord azimuth and distance being 333° 15' 46" 108.39 feet to a 3/4-inch pipe;
3. 51° 00' 1197.46 feet along Lot 3, Kapahi Farm Lots, to a 3/4-inch pipe;
4. 134° 42' 20.07 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;
5. 169° 31' 130.60 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;
6. 137° 26' 327.50 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;
7. 98° 31' 103.50 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;
8. 146° 21' 75.20 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;

- 9. 176° 36' 60.30 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;
- 10. 152° 52' 209.40 feet along Grant 8726 to Lawrence J. Mundon (Lot 77, Kapaa Homesteads First Series) to a 3/4-inch pipe;
- 11. 246° 43' 1357.42 feet along Lot 1, Kapahi Farm Lots, to the point of beginning and containing an Area of 20.00 Acres.

Reserving to the Territory of Hawaii in perpetuity for itself, its lessees, licensees and grantees an Easement fifteen (15.00) feet wide for Ditch 8-B South Branch over, upon and across the above-described Lot 2 together with rights of ingress and egress thereto for maintenance, inspection, re-construction and repair of said ditch. Said Easement being shown on the plan attached hereto and made a part hereof.

Said Easements C, D^G and F being shown on the plan attached hereto and made a part hereof.
