Beginning at an iron rail at the Northeast corner of this lot, the West edge of the Kaupakulua Gulch and on the <sup>North</sup> side of the Spreckels' Hawaiian Commercial & Sugar Company's ditch, the coordinates of said rail referred to Government Survey Trig. Station "Kauhikoa" being 14296.4 feet North and 4403.2 feet East, as shown on Government Survey Registered Map No. 2466, and running by true azimuths:-

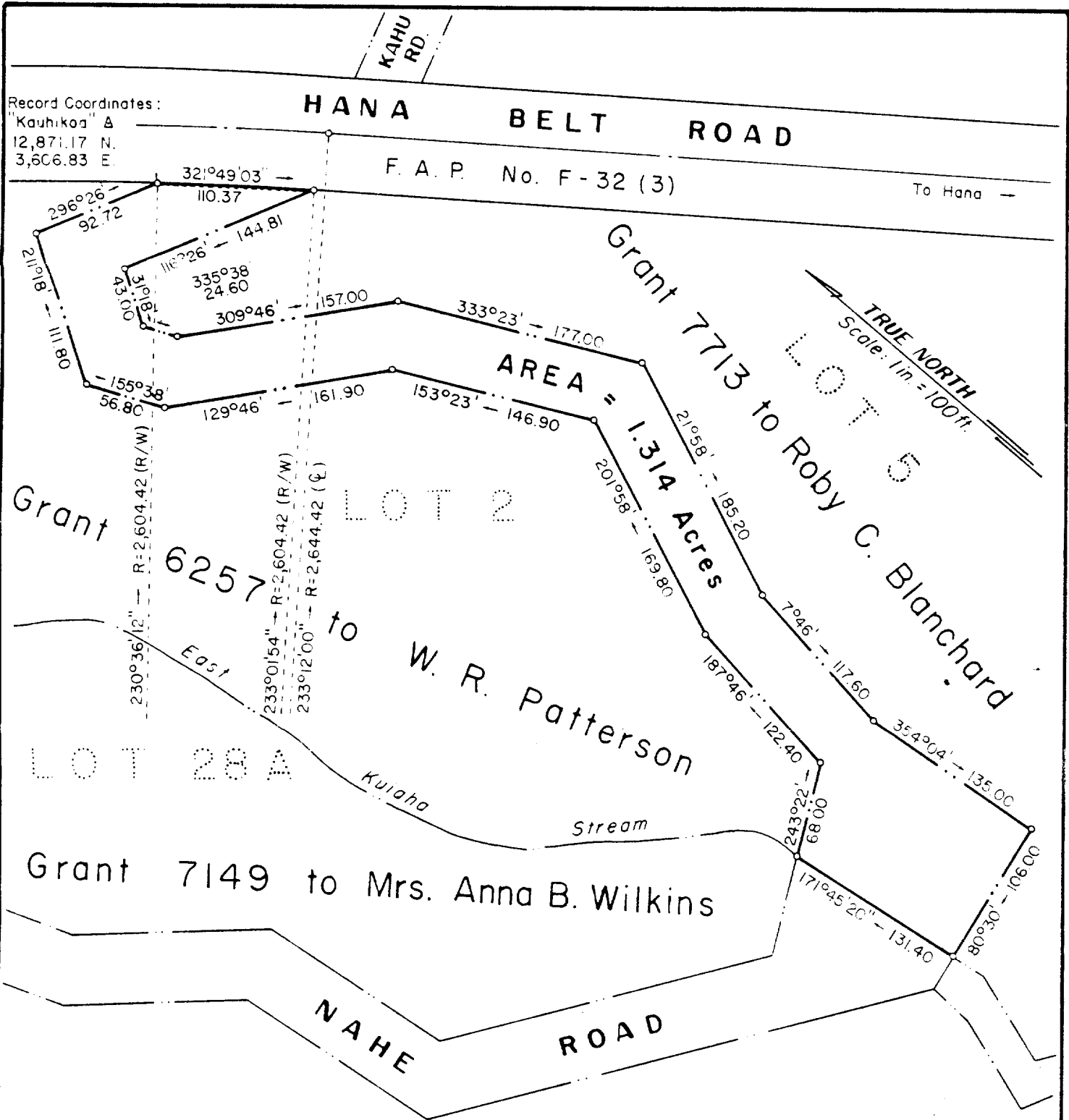
