Beginning at a 2 inch galvanized iron pipe at the Northeast corner of this lot and the Northwest corner of Lot 3 and on the South side of 40 foot road, the coordinates of said point of beginning referred to Government Survey Trig. Station "Alala" being 1906.7 feet South and 297.5 feet East, as shown on Government Survey Registered Map No. 2497, and running by true azimuths:-

1. 68° 03' 417.4 feet along road to a 2 inch galvanized iron pipe;
2. 1° 15' 129.1 feet along road to a 2 inch galvanized iron pipe;
3. 8° 20' 349.0 feet along road to a 2 inch galvanized iron pipe;
4. 358° 55' 146.1 feet along road to a 2 inch galvanized iron pipe;
5. Southwesterly along a curve to the right with a radius of 232.9 feet to point of tangency, the direct azimuth and distance being 25° 10' 206.0 feet;
6. 51° 25' 230.0 feet along road to point of curve;
7. Thence Southwesterly along a curve to the left with a radius of 213.2 feet to point of tangency, the direct azimuth and distance being 28° 30' 166.0 feet;
8. 5° 35' 50.0 feet along road to point of curve;
9. Thence Southwesterly along a curve to the right with a radius of 107.5 feet to point of tangency, the direct azimuth and distance being 37° 15' 112.8 feet;

- 10. 68° 55' 82.1 feet along road to a 2 inch galvanized iron pipe;
- 11. 49° 55' 163.4 feet along road to a 2 inch galvanized iron pipe;
- 12. 29° 10' 88.3 feet along road to a 2 inch galvanized iron pipe;
- 13. 335° 04' 107.0 feet along Lot 1 to a 2 inch galvanized iron pipe;
- 14. Thence Northeasterly along the top of the pali near the edge of the Waiama Gulch, the direct azimuth and distance being 249° 32' 1145.3 feet;
- 15. 180° 00' 21309.7 feet along Lot 3 to the point of beginning.
