Station "Papaaloa", as shown on Government Survey Registered Map No. 2256, and running by true azimuths:-

1. 336° 45' 885.0 feet along Government land to a post marked III on the ^{top of the} Northwest bank of Kilau Gulch;
2. Along the ^{top of the} Northwest bank of Kilau Gulch, the direct azimuth and distance being: 33° 10' 1482.0 feet to a post marked III ;
3. 71° 34' 249.0 feet along 50 foot road reserve;
4. 161° 40' 490.0 feet along 50 foot road reserve;
5. 219° 35' 293.0 feet along 50 foot road reserve;
6. 182° 09' 370.0 feet along 50 foot road reserve;
7. 95° 28' 142.0 feet along 50 foot road reserve to a post marked III on the East bank of Kapili Gulch;
8. 186° 45' 630.0 feet along the ^{top of the} East bank of Kapili Gulch;
9. 239° 20' 835.0 feet along the ^{top of the} Southeast bank of Kapili Gulch to the point of beginning.

Notes of Survey

- Beginning at the North angle, at pool below falls in the Pahale stream, said point bearing $S 63^{\circ} 02' E.$ true dist. 890 ft. from the \times + 12" iron tube known as the Heine Gort Survey Reference Pt. "Mogatellulucika", the boundary runs by true bearings
- 1 - $S 63^{\circ} 02' E.$ - 1677 ft. along lower edge of woods to post marked III at West edge of roadway
 - 2 - $S 53^{\circ} 47' W.$ - 2390 ft. - along West edge of roadway 40 ft. wide, separating this section from section * 2. to post marked III at South angle
 - 3 - $N 62^{\circ} 22' W.$ - 899 ft. - along East forest remainder to \triangle marked on rock in middle Pahale stream
 - 4 - $N 34^{\circ} 56' E.$ - 2165 ft. - along middle of Pahale stream to falls & down the same to point of beginning.

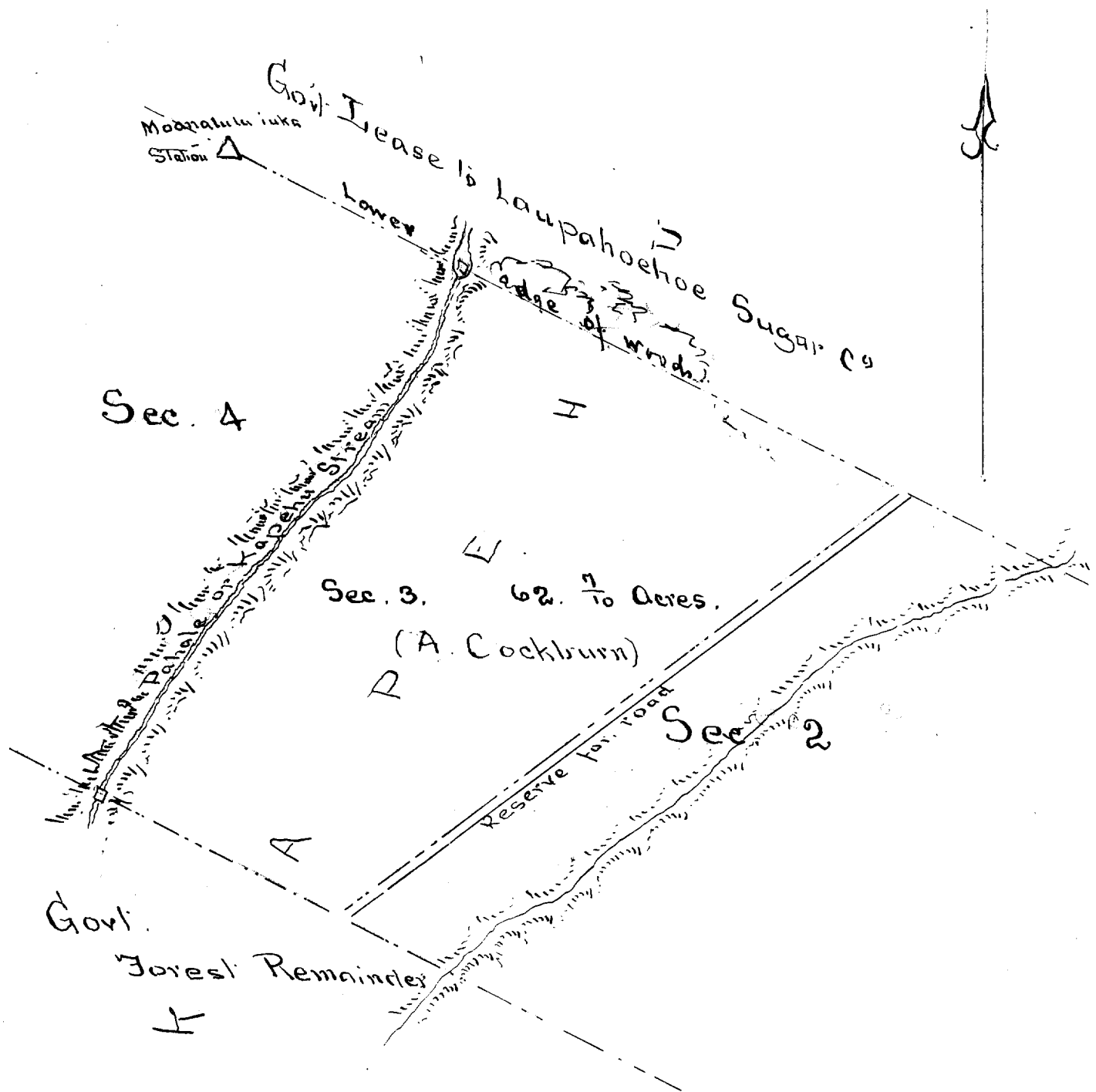
