Being a portion of the Government Land of Weliweli.

Beginning at the southwest corner of this lot, the southeast corner of Lot 6, Weliweli Makai Lots and on the north side of Poipu Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LAAUKAHI" being 23925.23 feet South and 2485.16 feet East, as shown on Government Survey Registered Map HTS Plat 3092, thence running by azimuths measured clockwise from True South:-

1. 176° 25' 58.62 feet along Lots 6 and 8 of Weliweli Makai Lots;
2. 257° 55' 36.91 feet along Lot 8, Weliweli Makai Lots;
3. 348° 30' 29.17 feet along R.P. 3750, L.C.Aw. 3359, Apana 1 to Niihau;
4. 14° 22' 46.55 feet along portions of Grant 1408 to Kauiahewa and Grant 1406 to Eke Opunui;
5. 105° 33' 27.71 feet along the north side of Poipu Road to the point of beginning and containing an Area of 2371 Square Feet.
