3. S. 38° 00' East 1099.3 feet along Lot 65 (Grant 4017 to W. Vredenberg);
4. S. 48° 46' West 402.7 feet along North side of 20 Foot Homestead Road;
5. S. 84° 41' West 161.8 feet along same to the point of beginning.

Station "West Base" being 1916 feet North and 4126 feet East, as shown on Government Survey Registered Map No. 1795, the boundary runs:

1. N. 30° 30' E. true 440 feet along 20 ft. Homestead Road to the East corner of this lot, the boundary however following the windings of a road laid out along Lot 41;
2. N. 30° 53' W. true 1081 feet along Lot 64 to the North corner;
3. S. 89° 49' W. true 449 feet along 10 ft. Homestead Road to the West corner of this lot, the boundary however following the windings of a road laid out along Lot 68;
4. S. 30° 53' E. true 1521 feet along Lot 62, Grant 6430, to L. Kepai, to the initial point.
