Beginning at the northeast corner of this lot, the southeast corner of Lot 9 of Weliweli Makai Lots and on the west side of Kuai Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LAAUKAHI" being 23831.72 feet South and 2355.41 feet East, as shown on Government Survey Registered Map HTS Plat 3092, thence running by azimuths measured clockwise from True South:-

1. 14° 18' 34.73 feet along the west side of Kuai Road;
2. Thence still along the west side of Kuai Road, on a curve to the right having a radius of 20.00 feet, the chord azimuth and distance being:
59° 55' 30" 28.59 feet;
3. 105° 33' 96.98 feet along the north side of Poipu Road;
4. 193° 27' 54.92 feet along the land of Koloa (Boundary Certificate No. 27);
5. 285° 25' 118.23 feet along Lot 9 of Weliweli Makai Lots to the point of beginning and containing an Area of 6392 Square Feet.
