1. 28° 30' 2066.0 feet along Lot 8 to a post marked VII-VIII;
2. 118° 30' 1317.0 feet along Government Land to a post marked VII;
3. 208° 30' 612.0 feet along Government Land to a Δ marked on opika tree (new mark);
4. Along center of gully along Grant 4148 to Okamura, the direct azimuth and distance being:- 216° 59' 939.0 feet to an arched koa at gully;
5. Continuing down center of gully along Grant 4178 to C.E. Steel, the direct azimuth and distance being:- 229° 20' 643.0 feet to a point in Kapili Gulch, from which point a Δ marked on stone bears 196° 30' 26 feet;
6. 260° 22' 177.0 feet along 50 foot road reserve;
7. 292° 48' 180.0 feet along 50 foot road reserve;
8. 306° 29' 228.0 feet along 50 foot road reserve;
9. 321° 28' 438.0 feet along 50 foot road reserve to the point of beginning.

Notes of Survey.

Beginning at a post marked ~~VII~~^{VII} standing 40 feet distant and bearing N. 65° 25' W. "true" from the ohia tree marked Δ at the foot of which is set a 12" wrought iron tube, the co-ordinates of said ohia tree referred to the Haw'n. Gov't. Survey Δ ¹³⁷ Sta. "Papaaloa" being South 3898 ft.)
West 4057 ft.) - the boundary runs by true bearings.

- 1.- N. 65° 25' W. 955 ft. along lower rdge of forest to post at North angle.
- 2.- S. 25° 27' W. 1990 ft. along Section #8 to West angle at ohia $\Delta \Delta$
