LOT 7-A - Being land situate between the northwest boundary of Lot 7 of Puako House Lots and highwater mark at seashore.

Beginning at the southwest corner of this parcel of land, the west corner of Lot 7, Puako House Lots (Grant 9967 to Mrs. Annie Paulo), and on the east boundary of R.P. 5010, L.C. Aw. 3736 Apana 4 to Wahakane, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUAKO" being 1404.42 feet South and 1408.48 feet West, as shown on Government Survey Registered Map 1974, and running by azimuths measured clockwise from True South:-

1. 154° 00' 95.00 feet along R.P. 5010, L.C. Aw. 3736 Apana 4 to Wahakane;

Thence along the seabeach at highwater mark for the next two (2) courses, the direct azimuths and distances between points being:

2. 259° 00' 100.00 feet;
3. 215° 25' 219.46 feet; thence
4. 346° 29' 100.00 feet along fence along government land;
5. 36° 05' 136.40 feet along Lot 7, Puako House Lots (Grant 9967 to Mrs. Annie Paulo);
6. 59° 06' 147.70 feet along same to the point of beginning.
