8. 332° 15' 510.2 feet along Grant 2724:2 to Kalikē to a pipe;
9. 105° 05' 1117.0 feet along Grant 1377 to Sanford to a pipe;
10. 97° 25' 716.0 feet along L.C.A. 7542 to Kahaliukua to a pipe;
11. 140° 32' 426.0 feet along land of Kahilipalinui to a pipe;
12. 152° 41' 570.0 feet along land of Kahilipalinui to a pipe;
13. 230° 15' 1321.0 feet along Lot 8 to the point of beginning.

Excepting and reserving therefrom that portion of the 40 foot road (area 1-50/100 acres) within this lot, LEAVING A NET AREA OF 49-30/100ACRES.
