Beginning at the South corner of this lot, the East corner of Lot 10, and on the North side of a 30 foot Homestead Road, the co-ordinates of said point of beginning referred to Government Survey Trig. Station "Kauku" being 1625 feet North, and 6994 feet East, as shown on Government Survey Registered Map No. 2546, and running by true azimuths:-

1.  $161^{\circ} 30'$  1105.6 feet along Lot 10;
2. Thence along the middle of Kapehu Stream to a point, the direct azimuth and distance being  $252^{\circ} 02'$  624.7 feet;
3.  $341^{\circ} 30'$  1079.3 feet along Lot 12;
4.  $69^{\circ} 37'$  625.0 feet along 30 foot Homestead Road to the point of beginning.
