Beginning at a pipe at the North corner of this lot and the East corner of Lot 116, and on the Southwest side of a road, the coordinates of said point referred to Government Survey Trig. Station "Piholo" being 3990.8 feet South and 707.0 feet East, as shown on Government Survey Registered Map No. 2394, and running by true azimuths:-

1. 314° 46' 295.0 feet along road to a stake;
2. 241° 49' 34.3 feet along road to a pipe in middle of a gulch;
3. Thence up the middle of gulch along Lot 136 to the South corner of Lot 136, the direct azimuth and distance being: 335° 48' 602.0 feet, said point being 54° 45' 15.0 feet from a pipe on the East bank of the stream;
4. Thence still up the middle of the gulch along Lot 135 to the North corner of Lot 118, the direct azimuth and distance being: 297° 57' 161.8 feet, said point being 234° 45' 10.0 feet from a pipe on the West bank of the stream;
5. 54° 45' 949.6 feet along Lot 118 and across a 30 foot road to a stake on East side of a gulch, passing over a pipe at 10.0 feet;
6. 346° 49' 27.7 feet along road to a stake;
7. 10° 49' 92.0 feet along road to a stake;
8. 340° 37' 49.4 feet along road to a stake;

9. 288° 14' 80.2 feet along road to a stake;
10. 16° 20' 38.0 feet along road to a stake;
11. 74° 55' 88.0 feet along road to a stake;
12. 138° 37' 283.4 feet along road to a stake;
13. 78° 33' 92.3 feet along road to a stake;
14. 16° 55' 202.5 feet along road to a stake;
15. 54° 45' 813.0 feet along Lot 118 to the middle of a gulch, passing over a pipe at 793.0 feet;
16. Thence down the middle of the gulch along Lot 113 to the North corner of Lot 113, the direct azimuth and distance being: 125° 48' 53.5 feet, said point being 54° 45' 10.0 feet from a pipe on the East bank of the stream;
17. Thence still down the middle of the gulch along Lot 115 to the North corner of Lot 115, the direct azimuth and distance being: 176° 25' 1150.3 feet, said point being 54° 45' 15.0 feet from a pipe on the East bank of the stream;
18. 234° 45' 1563.0 feet along Lot 116 to the point of beginning, passing over a pipe at 15.0 feet.

Area 44-70/100 Acres.

Excepting and Reserving therefrom the homestead roads through this lot, as shown on plan hereto attached and made a part hereof, containing an area of 1-75/100 acres, LEAVING A NET AREA OF 42-95/100 ACRES.
