Being a portion of Grant 1157 to George W. Macy and James Louzada conveyed to the Territory of Hawaii by Richard Smart by Deed dated June 12, 1956 and recorded in Liber 3126 Pages 36-55 (Land Office Deed 13596).

Beginning at a pipe at the north corner of this lot, the east corner of Part B of Lot 18 of Lalamilo Farm Lots and on the southwest side of 40-Foot Roadway, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU PA" being 9144.16 feet North and 5486.90 feet East, as shown on Government Survey Registered Map H.S.S. Plat 420, thence running by azimuths measured clockwise from True South:-

1. 306° 30' 960.00 feet along the southwest side of 40-Foot Roadway to a pipe;
2. Thence along the westerly side of 40-Foot Roadway on a curve to the right having a radius of 50.00 feet, the chord azimuth and distance being: 351° 30' 70.71 feet to a pipe;
3. 36° 30' 750.00 feet along the northwest side of 40-Foot Roadway to a pipe;
4. 126° 30' 1010.00 feet along Lot 19 of Lalamilo Farm Lots to a pipe;
5. 216° 30' 800.00 feet along Part B of Lot 18 of Lalamilo Farm Lots to the point of beginning and containing an Area of 18.537 Acres.
