Beginning at an iron pipe at the Northwest corner of this lot and on the South side of Government road on the boundary of Kalaheo, from which point the true azimuth and distance to Trig. Station "Kekaunahoa" is $204^{\circ} 05'$ 343.1 feet, and the coordinates of said point of beginning referred to Government Survey Trig. Station "Kalua-moa" are 6806.1 feet South and 3510.0 feet West, as shown on Government Survey Registered Map No. 2493, and running by true azimuths:-

1. $291^{\circ} 57'$ 171.4 feet along South side of Government Road to a + on stone;
2. $283^{\circ} 25'$ 254.4 feet along South side of Government road to a + on stone;
3. $244^{\circ} 15'$ 75.12 feet along South side of Government road to a + on stone;
4. $304^{\circ} 04'$ 588.0 feet along Lot 18 across a ditch to a pipe; ~~on the West side of stream;~~
5. $61^{\circ} 29'$ 175.5 feet; ~~along stream to a point;~~
6. $50^{\circ} 24' 30''$ 275.9 feet; ~~along stream to a point;~~
7. $54^{\circ} 32'$ 103.3 feet ~~along stream~~ to a + on stone;
8. $133^{\circ} 13'$ 242.1 feet; ~~along stream to a point;~~
9. $152^{\circ} 07'$ 310.5 feet ~~along stream~~ to a + on boulder;
10. $93^{\circ} 51'$ 111.9 feet ~~along stream~~ to a + on rock;
11. $30^{\circ} 41'$ 172.5 feet ~~along stream~~ to a + on rock;

- 12. 351° 28' 250.2 feet ~~along stream~~ to a + on boulder;
- 13. 157° 32' 30" 418.0 feet to a + on stone on boundary of Kalaheo;
- 14. 204° 04' 330.6 feet along the land of Kalaheo to the point of beginning.

Area 8-68/100 Acres.

Excepting and Reserving therefrom a 15 foot right-of-way for the ditch across this lot, said right-of-way containing an area of 25/100 acre, LEAVING A NET AREA OF 8-43/100 ACRES.
