Being a portion of Grant 1157 to George W. Macy and James Louzada conveyed to the Territory of Hawaii by Richard Smart by Deed dated June 12, 1956 and recorded in Liber 3126 Pages 36-55 (Land Office Deed 13596).

Beginning at a pipe at the east corner of this lot, the south corner of Lot 19 of Lalamilo Farm Lots and on the northwest side of 40-Foot Roadway, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU PA" being 7578.77 feet North and 5585.00 feet East, as shown on Government Survey Registered Map H.S.S. Plat 420, thence running by azimuths measured clockwise from True South:-

1. 36° 30' 400.00 feet along the northwest side of 40-Foot Roadway to a pipe;
2. 126° 30' 2160.00 feet along Part B of Lot 21 of Lalamilo Farm Lots to a pipe;
3. 216° 30' 400.00 feet along land owned by the State of Hawaii to a pipe;
4. 306° 30' 2160.00 feet along Lot 19 of Lalamilo Farm Lots to the point of beginning and containing an Area of 19.835 Acres.
